

# United Nations independent human rights experts submissions to the European Union in 2025

The <u>Special Procedures of the Human Rights Council</u> comprise independent human rights experts with mandates to report and advise on human rights from a thematic (e.g., the freedom of expression or the right to food) or country-specific perspective. The system of Special Procedures is a central element of the United Nations human rights architecture and covers all human rights: civil, cultural, economic, political, and social. As of November 2025, there are 46 thematic and 13 country mandates. With the support of the Office of the United Nations High Commissioner for Human Rights (OHCHR), special procedures:

- Undertake country visits,
- Act on individual cases of reported violations and concerns of a broader nature by sending communications to States and others,
- · Contribute to the development of international human rights standards, and
- Engage in advocacy, raise public awareness, and provide advice for technical cooperation.
