Introduction

The 1945 United Nations Charter proclaims that one of the purposes of the United Nations is to promote and encourage respect for human rights and fundamental freedoms for all. In this context, the Universal Declaration of Human Rights, adopted by the United Nations General Assembly in 1948, spells out the fundamental rights and freedoms that all human beings should enjoy. Its provisions have been developed in international human rights treaties, including the International Covenant on Civil and Political Rights and the International Covenant on Economic, Social and Cultural Rights.

This document outlines past and forthcoming engagement of the European Union and the member States of the European Union with the three United Nations human rights mechanisms which oversee the implementation of the international human rights treaties. At the outset, it explains these mechanisms and outlines which international human rights treaties have been ratified by the European Union and its member States before going into the details of the European Union's and each member States engagement with them.



The Universal Declaration of Human Rights laid the groundwork for the human rights architecture that is nowadays composed of the main human rights mechanisms overseeing implementation of the international human rights treaties in the 193 member States of the United Nations:

The Human Rights Treaty Bodies

Committees of independent experts that monitor implementation of the core international human rights treaties. These Treaty Bodies usually meet in Geneva, Switzerland, and are supported by the Human Rights Treaties Division of the Office of the High Commissioner for Human Rights (OHCHR). The Treaty Bodies perform a number of functions in accordance with the provisions of the treaties that established them.

Treaty Bodies thematic focus and working methods all differ slightly, but in general, they:

- Consider States parties' reports;
- Consider individual complaints;
- Conduct country inquiries;
- Adopt **general comments** and organize thematic discussions to interpret the provisions of their treaty or treaties;
- Attend the annual meeting of Chairpersons; and
- Contribute to the treaty body strengthening process.

The Universal Periodic Review (UPR)

The Universal Periodic Review (UPR) is a unique mechanism of the Human Rights Council that calls for each UN Member State to undergo a peer review of its human rights records every 4.5 years. Established in March 2006 by the UN General Assembly in resolution 60/251, the UPR is designed to prompt, support, and expand the promotion and protection of human rights in every country.

The UPR provides each State the opportunity to regularly:

- Report on the actions it has taken to improve the human rights situations in their countries and to overcome challenges to the enjoyment of human rights.
- Receive recommendations informed by multi-stakeholder input and pre-session reports from UN Member States for continuous improvement.

Since the first periodic review in 2008, all 193 UN Member States have been reviewed three times. The fourth cycle of review began in November 2022, at the 41st session of the UPR Working Group.

The Special Procedures of the Human Rights Council

The term 'Special Procedures' refers to independent human rights experts with mandates to report and advise on human rights from a thematic (e.g., the freedom of expression or the right to food) or country-specific perspective.

The system of Special Procedures is a central element of the United Nations human rights machinery and covers all human rights: civil, cultural, economic, political, and social. As of January 2025, there are 46 thematic and 14 country mandates. With the support of the Office of the High Commissioner for Human Rights (OHCHR), special procedures:

- Undertake country visits
- Act on individual cases of reported violations and concerns of a broader nature by sending communications to States and others
- Contribute to the development of international human rights standards, and
- Engage in advocacy, raise public awareness, and provide advice for technical cooperation.

In conclusion, these human rights mechanisms have different mandates, procedures and activities, which in turn shape the ways in which (i) States in their capacity as duty-bearers, (ii) individuals as the rightsholders, (iii) other national or international stakeholders (NHRIs, CSOs etc.), and (iv) the United Nations Country Teams (UNCT), engage with them.

Some mechanisms conduct country visits or inquiries to monitor specific human rights issues; others consider complaints by individuals who allege that their rights have been violated by a State; and almost all of them have an established reporting procedure for assessing the progress of States in meeting their human rights obligations.

Independently of their functions, **all three mechanisms generate recommendations** to the States with the aim of contributing to short-term and long-term changes in legal and policy frameworks to improve human rights protection.

All recommendations addressed to European Union (EU) member States through the UPR, by Treaty Bodies or by Special Procedure mandate-holders are available on the OHCHR [Universal Human Rights Index](#). This database can be searched by country, human rights theme, SDG, affected group and by human rights mechanism.

National mechanism for implementation, reporting and follow-up

In order to effectively implement the recommendations they receive, some EU member States have established a national mechanism for implementation, reporting and follow-up (NMIRF) to facilitate implementation of recommendations from Treaty Bodies, the UPR and Special Procedures.

NMIRFs are Government structures mandated to coordinate the preparation of reports to, and engage with, international and regional human rights mechanisms and to facilitate national follow-up and implementation of human rights treaty law obligations and the recommendations emanating from those mechanisms.

The establishment of NMIRFs was a key recommendation of the UN High Commissioner for Human Rights' report on treaty body strengthening in 2012 ([A/66/860](#)), paving the way for GA resolution 68/268 on "Strengthening and enhancing the effective functioning of the human rights treaty body system".

This resolution recognizes the need for improved coordination of reporting at the national level (para.20) and the importance of exchanging on best practices.

RATIFICATION OF INTERNATIONAL HUMAN RIGHTS TREATIES

The European Union and its member States are parties* to various human rights treaties adopted under the auspices of the United Nations.

There are 9 core international human rights instruments. These treaties cover a wide range of issues such as civil, political, economic, social, and cultural rights. Below is a list of key United Nations human rights treaties and the status of their ratification or accession by EU member States.

THE EUROPEAN UNION AND UN HUMAN RIGHTS MECHANISMS

Treaty Bodies

The EU and its member States report regularly to human rights treaty bodies on the measures they have adopted relating to the rights described in the Convention, and on the progress the State has made in upholding them.

Special Procedures

The EU and its member States support the work of special procedures and engage in international fora to strengthen their functioning and impact.

All EU member States have issued standing invitation to all thematic special procedures, announcing that they will always accept requests for visits from all special procedures mandate holders.

UPR

The EU and its member States are strongly committed to the Universal Periodic Review (UPR) mechanism and to the effective implementation of UPR recommendations. During the previous three cycles, all EU member States actively participated in the UPR mechanism, contributing to its success.

18 EU member States have already undergone their review during the fourth cycle, currently underway, while the remaining 9 member States will be reviewed before the end of the cycle. So far, EU member States have received **more than 17,000 recommendations**.

In the last 5 years, the EU and its member States welcomed 37 independent experts on a country visit. Some visits are still pending. For additional information, see the [special procedures country visit database](#).

The EU and its member States also engage with special procedures through the communication procedures by responding to individual communications addressed to them. In the last 5 years, the EU, its member States and other actors received and addressed more than 350 cases of alleged human rights violations sent by thematic and country mandates. NATIONAL MECHANISM FOR IMPLEMENTATION, REPORTING AND FOLLOW-UP

Italy's standing national mechanism is the Interministerial Committee for Human Rights (in Italian, Comitato Interministeriale per i Diritti Umani), established by Ministerial Decree and housed within the Ministry of Foreign Affairs.

CIDU coordinates Italy's engagement with international and regional human rights mechanisms and includes representatives from nearly all ministries, local governments, and statistical bodies.

Institutional setup and mandates

The CIDU was established by Ministerial Decree No. 519/1978 and integrated by Ministerial Decree No. 2000/517/2013 within the Ministry of Foreign Affairs and International Cooperation adopted on 5 September 2013.

Composition

CIDU's members are appointed from their respective Administrations or bodies, at the highest level (by the Minister or his/her Chef of Cabinet or by the Secretary-General or General Directors). CIDU gathers representatives from: Presidency of the Council of Ministers; Ministry of Justice; Ministry of Interior; Ministry of Education; Ministry of Labour; Ministry of Health; Ministry on Economic Development; Ministry of Defence; Ministry on Environment; Ministry on Agriculture; Ministry on Cultural Heritage; National Office against Racial Discrimination; Superior Council of the Judiciary (CSM); National Office of Statistics (ISTAT); Carabinieri Corps; Revenue Guards Corps (Guardia di Finanza); National Association of Italian Municipalities (ANCI); Union of Italian Provinces (UPI); Conference of Regions and Autonomous Provinces; Italian Society for International Organizations (SIOI)); CREA; CNEL; Italian Commission-UNESCO.

Secretariat

CIDU has a permanent Secretariat. The CIDU Secretariat includes a Secretary-General, who is an external figure appointed by the Minister of Foreign Affairs, and human rights consultants recruited among lawyers and university professors with a sound experience in Human Rights. Finally, three eminent personalities from the academic and scientific world, appointed by the Minister of Foreign Affairs and International Cooperation, are also members of CIDU.

Mandate

CIDU ensures the coordination of the Italian government action with regard to its obligations under international human rights agreements, and in particular the Conventions to which Italy is a party. Within the United Nations framework, CIDU engages with the UN High Commissioner for Human Rights (OHCHR) and the Committees (Treaty Bodies) established under the various Conventions, as well as the Human Rights Council mechanisms, including Special Procedures and the Universal Periodic Review.

At a regional level, CIDU interacts with the EU Agency for Fundamental Rights (FRA), based in Vienna, and the European Commission against Racism and Intolerance (ECRI), based in Strasbourg. In these two institutions, CIDU's President acts as National Liaison Officer (NLO). Within the Council of Europe, CIDU engages also with the European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT), coordinating the country visits.

NATIONAL MECHANISM FOR IMPLEMENTATION, REPORTING AND FOLLOW-UP

Portugal has a permanent standing national mechanism for implementation, reporting and follow-up, entitled the National Human Rights Committee (Comissão Nacional para os Direitos Humanos). All information on the Committee can be found on its [website](#).

Institutional setup and mandates

The National Human Rights Committee (NHRC) was established by [Resolution of the Council of Ministers no. 27/2010](#).

It is composed of representatives from 18 government areas, each of which nominates a focal point and a deputy focal point. There is, however, flexibility to add extra contact points. The NHRC also includes 4 permanent observers:

- Parliament
- the Public Prosecutor's Office
- the Ombudsperson
- the National Association of Portuguese Municipalities.

The President of the NHRC is the Secretary of State for Foreign Affairs and Cooperation while the Vice-President is the Deputy Director-General for Foreign Policy, responsible for multilateral affairs.

Secretariat

The Human Rights Unit (which is part of the Department for Multilateral Political Organizations at the Directorate-General for Foreign Policy of Portugal's Ministry for Foreign Affairs) serves as the Executive Secretariat of the NHRC. The Unit is headed by a career diplomat and is currently composed of five desk officers as well as an intern. Two of these desk officers hold responsibility for the Committee's Executive Secretariat, including managing daily communications via the Secretariat's email inbox.

Mandate

The law which created the NHRC provides it with seven tasks:

1. guaranteeing interministerial coordination to define Portugal's positions in multilateral human rights fora and to ensure the fulfilling of its international human rights obligations;
2. monitoring the implementation of Portugal's international human rights obligations by line ministries;
3. proposing the adoption of internal measures (whether of a legislative or non-legislative nature) to comply with Portugal's international human rights obligations;
4. ensuring the timely submission of reports to multilateral human rights mechanisms;
5. proposing Portugal's ratification of international human rights instruments;
6. promoting and disseminating good practices, both those developed in Portugal and those observed internationally, with a view to their potential adaptation or implementation at the national level;
7. promoting the dissemination of knowledge and initiatives on human rights, including studies and events.

As such, this broad mandate allows the NHRC to engage with all international human rights monitoring mechanisms, both at the UN level (Treaty Bodies, Special Procedures, Universal Periodic, Human Rights Council, etc.) and at the regional level (namely the Council of Europe).

NATIONAL MECHANISM FOR IMPLEMENTATION, REPORTING AND FOLLOW-UP

Slovenia's National Mechanism for Implementation, Reporting and Follow-up (NMIRF) is the Inter-departmental Commission on Human Rights (ICHR), composed of representatives from government ministries, statistical and law enforcement bodies, civil society, and academia. It coordinates reporting to international human rights mechanisms and monitors implementation of obligations.

Institutional setup

The Inter-departmental Commission on Human Rights (ICHR) was established by a Decision of the Government of the Republic of Slovenia No. 01201-2/2013/4, which was amended by Decisions No. 01201-2/2013/10, No. 01201-1/2015/3 and No. 01201-4/2024/3. These are not available in English.

The Inter-departmental Commission on Human Rights (ICHR) includes representatives from the following ministries and departments: Office of the Prime Minister; All line ministries; National Statistical Office; Police; Office for National Minorities; Office for the Support and Integration of Migrants; Civil society and academia.

Secretariat

There is no permanent secretariat. The Ministry of Foreign and European Affairs nominates the president and secretary and coordinates the work.

The Ministry of Foreign and European Affairs nominates the president and secretary of the ICHR and furthermore organizes and coordinates its work. The relevant line ministries draft reports and follow up on recommendations but these are debated and confirmed by the ICHR prior to being adopted by the Government.

Mandate

The Terms of Reference were defined in the Decision of the Government of the Republic of Slovenia No. 01201-2/2013/4, which established the ICHR. These are as follows:

The ICHR coordinates reporting to ratified international instruments for the protection of human rights and freedoms, reporting based on other mechanisms, and monitors the implementation of accepted obligations in the field of human rights.

The ICHR cooperates with the representatives of other institutions and civil society and, if necessary, invites them to its meetings.

Every second year, the ICHR reports on its work to the Government of the Republic of Slovenia and, if necessary, proposes relevant decisions to it for adoption.
